- 2. Firms may bid for PART-A only (<u>Unserviceable stores</u>), or may bid for PART-B only (<u>Callaghan Machine</u>), or may bid for both Part A & Part B.
- 3. The Earnest Money Deposit for Part-A is Rs.5000/-, for Part-B is Rs.10,000/- and for both Part A & B the EMD amount is Rs.15,000/-. The EMD must be deposited in the form of demand draft only drawn in favour of %CAR NIRJAFT+and payable at any Nationalized Bank in Kolkata sent through post /submit in person in original up to the bid submission end date. A scanned copy of the DD should be attached in online bid as mentioned under technical bid. - 7. - 8. Amount quoted will be treated as net price of the Lot on sis where is basis+both for Part A & Part B mentioned in the BOQ. The award of Contract will be given Lot-wise on Maximum price (H-1) quoted for each part.
- 9. The bidder is required to reveal his full name/ name of authorized signatory of the firm, full postal address & mobile No. It is required to submit documentary evidence in support of residential status (Ration card/ Voter id card in case of individuals & registration certificate in case of firms).

- 10. - 12. In case the total quantity to be disposed of cannot be taken up by the highest acceptable bidder, the remaining quantity may be offered to the next higher bidder(s) at the price offered by the highest acceptable bidder.
- 13. EMD of the successful bidder(s) will be released only after completion of sale process. No interest will be given on EMD value.
- 14. The delivery of the said items will be arranged only after the successful bidder produces original documents of identity in support of the copy of certificate he has uploaded in the e-tender on CPP Portal.
