The bidders are required to submit copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. More information useful for submitting the online bids on the CPP Portal is available/obtained at URL:http://eprocure.gov.in/eprocure/app. Manual/offline bids shall not be accepted under any circumstances.
- 2. For Registration Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL:http://eprocure.gov.in/eprocure/app) by clicking on the link "Click here to Enroll". Enrolment on the CPP Portal is free of charge.
- 3. Foreign Bidders have to refer "DSC details for foreign Bidders" for Digital signature Certificates requirements which comes under Download Tab at http://eprocure.gov.in/eprocure/app?page=Standard Bidding Documents &service=page and the remaining part is same as above and below.
- 4. No extra payment shall be paid on account of any discrepancy in nomenclature of items.

a) Price Bid as BoQ.xls- Quoted price must be including of all manpower, labour, material to be used, transportation, uniform, ESI, EPF, and taxes etc. ICAR NINFET will not bear any extra cost on any account.

Terms and conditions for tender

Pest Control and Anti Termite treatment:

- 1) Pest Control and Anti Termite treatment is to be done to the outside of foundation with chemical emulsion by admixing chloropyrofos emulsifiable concentrate (1% concentration) with water by weight, drilling 12 mm diameter holes in concrete or masonry aprox an interval of 300 mm, to a depth of 300mm or more as close to the plinth wall as possible and the chemical emulsion pumped into those holes to soak the soil below at a rate of 2.25 linear metre complete. Total length is about 1796 mtr.
- 2) Anti Termite Treatment to the soil under floor with chemical emulsion by admixing chloropyrofos emulsifiable concentrate (1% concentration) with water by weight including drilling vertically 12mm diameter holes at the junction of floor and wall at 300mm interval to reach the soil below using hand operated pressure pump to squirt chemical emulsion into the holes at the rate one litre per hole. The holes shall be sealed after operation to match with the existing floor. Total area is about 6842 sqm.
- 3) Mosquito treatment by anti mosquito fogging machine should be done in periphery of all building units of office and residence premises. Frequency: [24 visits for Thermal fogging and 48 visits for Larvae control] during the year depending on the mosquito population dynamics as per mutually pre decided program.
- 4) Spot application of insecticides should be done using aqua base spray for pests (for bugs, cockroaches, silverfish, spider, termites) in walls and ceiling etc with chemical emuslsion by admixing chloropyrofos emulsifiable concentrate (1% concentration) with water by weight including spraying the emulsified chemical @0.5 litres per sq. m by a hand operated pressure pump on wall surfaces, ceiling, on and around the pile of files electrical fixture, electrical lines including drilling holes in place where source of termite is detected squirting chemical solution into the holes with current grout. Rate is per sq mt of the floor area while actual work will be all walls, ceiling, rack, partition and furniture & should leave no space unattended. Total area is abount 12,770/- sq m.
- 5) Thermal fogging is to be carried out in common area within the institute campus. Common area (Road and service area) is about 5100 sq m.
- 6) Larvae control treatment (along boundary wall, drain, manhole, stagnant water, inspection chamber etc.) will be done by spraying of larvicides to stop breeding in any place of stagnant water.
- 7) Rodent Control is to be done as per requirement through use of treatment suitable for indoor and outdoor action as the case may be. The rodent carcass is to be collected and disposed outside the Institute campus. All costs required for suitable treatment for making the specified area rodent free must be included in the charge.
- 8) The contract also includes removal of nests of stinging insects within the property boundaries of specified buildings. The contractor will work with Environmental Compliance to identify options where bee hives can be relocated and not destroyed.
- 9) All chemicals, rodenticides, pesticides, devices etc. to be used should be safe and approved by Govt of India/ISI/BIS and should have the residual effect within the permitted limits.
- 10) Site cleaning after work completion has to be done by the firm.

- 11) All treatments should be carried out during working hours and there should not be any disturbance to the staffs working in the area. However, in canteen or in any emergency area if required, the treatment may be given in Sunday or Holiday. Sufficient persons should be sent for attending more than one block/building simultaneously so that the scheduled work can be completed in shortest possible time.
- 12) The quoted rates should include the cost of cleaning, material and sundries to be used, related labour and transportation charges, uniform, ESI, EPF, and taxes etc. ICAR NINFET will not bear any extra cost on any account. However the firm will clearly indicate taxes etc. as applicable.
- 13) No conditional bid will be accepted. The EMD will be refunded to the unsuccessful bidders as soon as practicable after a decision has been taken on the Tender and to the successful bidders after furnishing the required security deposit for the contract.
- **14)** The tender must be in the prescribed formats only and shall be accompanied with all other necessary documents.
- 15) The work shall be awarded to a single firm whose consolidated bid value is lowest meeting all scopes of work and fulfilling all the terms and conditions of the tender, with specific reference to the essential condition relating to the availability of requisites infrastructure/facilities and experience of similar nature.
- 16) The successful bidder shall have to deposit 10% of the total bid amount (calculated annually) as performance security and within the time frame indicated by the ICAR NINFET. Performance Security must be made valid till the end of 60 days beyond the expiry of the all contractual obligations including the Warranty obligations calculated from the date of award of contract. The same shall stand forfeited in case of cancellation of the contract for any breach of contract or for any deficiency in the performance noticed during the currency of the contract.
- 17) The tendering firm has to carefully assess the scope of work with specific reference to the inside and outside premises of the building and understand the details of the infrastructure/facilities requisitioned. The tenderer may, in their own interest, inspect the site i.e. inside and outside of ICAR NINFET, 12 Regent Park, Kolkata 700040, where the services are to be provided. - 18) No interest on Security Deposit and Earnest Money Deposit shall be paid by the ICAR NINFET to the tenderer. The firm is being permitted to give tenders in consideration of the stipulations on the his part that after submitting his tenders, he will not withdraw his offer or modify the terms and conditions thereof. If the tenderer fail to observe and comply with the foregoing stipulation the EMD will be forfeited by the ICAR NINFET.
- 19) The tenderer are liable to be ignored if complete information as required is not given therein or if the particular asked for in the schedules to the tenders is not fully filled in. Person signing the tenders or other documents must ensure that he is an authorized person on behalf of the firm to do so. The person signing the tenders form or any other documents forming part of the contract on behalf of another shall be deemed to warranty that he has authority to bind such other and if, on enquiry it appears that the person so signing had no authority to do so, ICAR NINFET shall without prejudice to other civil and criminal remedies cancel the contract and hold the signatory liable for all costs and damages. Each page of the tenders and the schedules to the tenders and annexure, if any, should be signed by the tenderer.
- 20) Acceptance by ICAR NINFET will be communicated by letter or any other form of communication. Formal letter of acceptance and work order of the Tenders will be forwarded as soon as possible, but the earlier instructions in the FAX, email/Express letter etc. should be

acted upon immediately.

- 21) The contract shall normally be awarded for a period of two years from the date of award or any shorter period that may be decided by the ICAR NINFET. The Contract will be strictly monitored as per Scope of work given in Annexure I in respect of minimum standard defined in the said Annexure. In case any shortcomings or deficiencies are noticed during the currency of contract period or any other contractual dispute, the contract can be terminated giving by giving one month notice. The decision of the Director, ICAR NINFET in this regard shall be final and binding.
- 22) The contract can be extended for further period of two more years on year to year basis subject to satisfactory performance of the firm at the same rate and terms & conditions.
- 23) If the contract is terminated on the grounds of glaring shortcomings or deficiencies during the currency of its tenure including extended tenure, if any, ICAR NINFET shall have all rights to make suitable alternative arrangements for a period of 45 days from the date of such termination or till a new tender is finalized whichever is earlier and the difference in cost, if any, will be borne by the agency/contractor.
- 24) The rates quoted by the Agency shall be fixed for the period of the contract and no request for any change/ modification shall be entertained before expiry of the period of the contract.
- 25) It is the obligation of the agency to follow the minimum wages issued by the appropriate Government under Minimum Wages Act, 1948. The ICAR NINFET shall have no liability, financial or otherwise, for any harm/damage/injury caused to the manpower/machinery deployed by the firm in the course of performing work of this Institute. Neither the firm nor its workers shall have any claim on ICAR NINFET for compensation or financial assistance on this account.
- **26**) It shall be the responsibility of the firm to comply with all the provisions of Acts, statutory requirements and Government instructions.
- 27) The service provider's personnel shall not divulge or disclose to any person any details of office, operation process, technical know-how, security arrangements, administrative and organizational matters as all of these are confidential in nature.
- **28)** The Agency shall issue necessary instructions to its employees to act upon the instruction given by the supervisory staff of the ICAR NINFET.
- 29) Mosquito Control/Thermal Fogging/Larvae Control will be done on regular basis as per scope of work. However, Anti-termite/ Pest Control and Rodent Control are need based, for which a formal requisition will be placed to you by I/c DDM.
- 30) Payment will be made through e transfer after every 06 months (half yearly basis) on production of tax invoice in duplicate and satisfactory work certificate from DDM section of ICAR NINFET. Bank Account No, Account Holders Name, Branch Name and IFSC code of the bank must be given in NEFT mandate form, failing of which payment will not be released. Tax will be deducted at source as per rule, if applicable.
- 31) Liquidated Damages clause:
- Contractor shall be responsible for the faithful compliance of scope of work mentioned in Annexure I.
- (ii) Any authorized person may inspect the premises to see the work carried out by the agency .Shortfall, if any, will be communicated to the agency/ contractor in writing/ email by ICAR NINFET. In the event of any shortfall or services found unsatisfactory, Liquidated Damage clause will be invoked by levying a penalty @Rs. 500/- per day. The Liquidated Damage amount will be deducted from the bill of the agency.
- (iii) After three such incidents of un-satisfactory reports, the contract shall be liable to be terminated. Performance Security will also be withheld in full or part. Final decision for invoking penalty will be taken at the level of Director, ICAR NINFET.
- **32**) Any dispute arising out of and in relation to this agreement shall be referred the Director, ICAR NINFET. His decision will be binding on the contractor

Scope of Work:

Scope of Work

The job of Anti-termite & Pest control shall include the following:

- i) General Pest Control/Anti Termite which means eradication of Cockroaches, Mosquitoes, Flies, Lizards, Termite, borer etc. through permitted insecticides as per Government of India and WHO norms. The Pest Control should cover all the places like spray under the tables, chairs, almirahs on and around the pile of files, on wooden furniture, on false ceiling, on all staircases, on lift lobby, on all toilets drain ducts, on all pantry rooms, in all stores and any hidden space under the furniture, as per requirement, and should leave no space unattended.
- ii) Rodent Control: Rodent control is to be done through use of treatment suitable for indoor & outdoor action, as per requirement, as the case may be. The rodent carcasses are to collected and disposed off outside the Institute campus
- iii) Adult Mosquito Control: Adult mosquito control treatment will be done by means of spraying and/or fogging to get rid of adult insects hidden in open and hidden places.
- iv) Larvae Control: Larvae control treatment (along boundary wall, drain, manhole, inspection chamber, stagnant water etc.) will be done by spraying of larvicides to stop breeding in any places of stagnant water.
- 2. Agencies must ensure that the Anti Termite treatment once done shall remain effective up to a period of at least one year failing which it shall have to be done again without any cost.
- 3. The pesticides etc. used for pest/rodent control should not have adverse impacts on human health.
- 4. Party/Firm/Agency is responsible for safety and health of their staff while working at the Institute.
- 5. Agencies are to visit the places of work for assessing the nature and volume of work realistically before quoting the rates.
- 6. The chemicals/pesticides used by the agency be purchased from reputed concern and should be ISI Marked and/or WHO approved.
- 7. List of some customers along with information regarding the name of at least one contact person/firm with address and phone/fax number should be given for reference.
- 8. Anti Termite/Pest control and Rodent control treatment will be taken up as per requirement only.
- 9. The area/length shown in Schedule of Work and BOQ is indicative only, showing the maximum requirement, if needed.
- 10. The Anti Termite/Pest control exercises are to be undertaken as per the frequency chart given below:
